Financial Commitments

Annual Supply/Registration fee: \$45/Child or \$95/Family

Tuition: 5 Days a week - \$299/Month, 3 days a week \$269/Month, 2 days a week \$249/Month, 1 day a week \$199/Month.

Early Registration: 5 days a week -\$269/month, 3 days - \$249/month, 2 days - \$229/month, 1 day \$179/month — — Must pay a \$100 non refundable deposit to hold your spot due June 1st 2022 (to hold your spot due June 1st to be applied to your first months tuition).

Fees are due whether your child is in attendance or not -For school holidays and inclement weather days there will be an all day option at \$59/day. **We only prorate at \$125/week if you join in the middle of the month, and we required a 30 days notice for dropping from our after school program.**

Failure to pay on time may result in termination of services. \$35 will be added to all returned checks. Courage Cheer and Dance may seek collection of fees: clients may be required to pay termination fee, any collection cost, and attorney fees incurred by Courage Cheer and Dance to collect this amount. Interest fee for unpaid tuition is set at 15% per month. If Courage Cheer and Dance elects, it may immediately terminate all services provided by it including but not limited to the immediate dismissal of the children from the facility. Courage Cheer and Dance may also prosecute under the Texas Penal code, Section 31.04-Theft of services.
